Town Board Meeting
Minutes
June 12, 2017

DRAFT: THESE HAVE NOT BEEN APPROVED BY THE TOWN BOARD

Chairman Derr called the meeting to order at 6:30 p.m. Present: Chairman Derr, Supervisors Grove and Willison, Clerk/Treasurer Bledsoe. Absent: none.

Pledge of Allegiance was recited.

Minutes of the May 8, May 18, and June 6, 2017 meeting were read. Grove moved to approve as written, Willison seconded. Motion carried.

Public comment: Town residents, Steve Weyenberg and Gary Jensen asked about the Town easement, between Hilton Lane and Northern Light Drive. Wondering who really owns the property and what the plans are. The easement is property of the Town of Bristol. Residents asked for this matter to be placed on the July meeting agenda, for the possibility for the Town to vacate the property, and pass it on to the property owners.

Review and consider a preliminary plat for Wellington Trace, a new subdivision located at the corner of Bird St., and Egge Rd., by Randy Marten and Blake & Geri Hart:

There was discussion between the Town Board members, the developer, and the engineer re: water levels, how much fill would have to be brought in to the new development, and what roads would be used for the trucks hauling in the fill. The next step will be for the parties to come to terms on a development agreement and to further study the potential water issues. This agenda item will be tabled for discussion at a later date TBD.

Review and consider the following license renewals for the 2017-18 license year:

“Class B” Beer/Liquor for Midway Roadhouse – Grove made the motion to approve upon all conditions being met, Willison seconded. Motion carried.

“Class B” Beer/Liquor for Red Door Inn – Willison made the motion to table this until Bledsoe can obtain more information from the WI DOR, Grove seconded. Motion carried.

“Class B” Beer/Liquor for North Bristol Sportsmen’s Club – Grove made the motion to approve upon all conditions being met, Willison seconded. Motion carried.

“Class B” Beer/Liquor for NV Corners – Willison made the motion to approve upon all conditions being met, including the specifics of where alcohol will be served on the premises, Grove seconded. Motion carried.

“Class B” Beer/Liquor for Sun Prairie Golf Course – Grove made the motion to approve, Willison seconded. Motion carried.

“Class B” Beer/Liquor and Adult Entertainment for Club Bristol – Grove made the motion to table this until all parties have come to an agreement on the safety plan and all other conditions being met, Willison seconded. Motion carried.

Treasurer’s Report was presented. Grove made the motion to approve, Willison seconded. Motion carried. Willison made the motion to audit and pay bills, Grove seconded. Motion carried.

Future meetings/agendas:

Town Board – If all parties are ready, there will be a Special Town Board meeting at 9 a.m. on June 26th. Also, due to Bledsoe attending the Clerks/Treasurers Institute at UW Green Bay in July, the regularly scheduled Town Board meeting in July has been moved from the 2nd Monday of the month (July 10th) to July 5th at 6:30 p.m.

Grove made the motion to adjourn, Willison seconded. Motion carried, meeting ended at 8:08 p.m.
